BEING A BY-LAW TO AMEND BY-LAW NO. 94-60 (PWO-2)
BEING THE BY-LAW TO ASSUME ROADS UNDER THE
JURISDICTION OF THE TOWN OF GEORGINA

WHEREAS the Council of the Town of Georgina may, pursuant to the Municipal Act, a Municipality may pass by-laws in respect of a highway only if it has jurisdiction over the highway. 2001, c. 25, s. 27 (1);

AND WHEREAS the Council of the Town of Georgina deems it necessary to assume the following portion(s) of road as a public highway:
