#### Swimming Pool/Hot Tub/Whirl Pools Enclosures

A Privately owned outdoor swimming pool (In-Ground Pool/Above-Ground Pool/On-Ground Pool) used for swimming in which the depth of water is 60 cm (24") or greater at any point and shall include spas, hot tubs and whirlpool required to be enclosed by a pool enclosure and require a building permit.

A hot tub, or whirl pool and that has a cover that may be locked and that will support a weight of at least 27.2 kg (60 pounds), is not required to be enclosed by a pool enclosure or temporary enclosure and does not require a permit prior to its installation and use. The owner of the hot tub /whirl pool shall ensure that the cover of such pool remains securely closed and locked at all times when such pool is not in use. Hot tub/Whirlpool shall be located in accordance with the setback requirements


The waste water from a Swimming Pool, hot tub/whirlpool shall be discharged to the sanitary sewer. Drainage cannot be directed onto neighboring properties. Pool enclosure that is a fence is required to be 1.2 meters (4'0") in height above ground and non-climbable

A completed building permit application form is required, accompanied by a digital copy of the following (if only paper copies are available contact <a href="mailto:building@georgina.ca">building@georgina.ca</a> for information):

- Site plan, showing the proposed location, setbacks, and the dimensions of the Swimming Pool/hot tub/whirlpool
- Pool Brochure
- Location of pump and filter and the water drainage directions must be shown
- Details of fence enclosure and self-closing/latching gate(s)
- Lot grading approval (From Engineering Division, if In-ground pool)
- Conservation Authority approval (if applicable)

Permit fee - In-Ground pool \$150.00/ Above —Ground Pool \$100.00/ On-Ground Pool \$50.00
