# Scope of Project

- Improve Road Pavement

Pavement has deteriorated and reached the end of its lifespan

- Improve Road Drainage

Culverts are clogged and ditches are full of sediment and do not drain. During rain and snow melt events, water sits on the road.



# Site Constraints

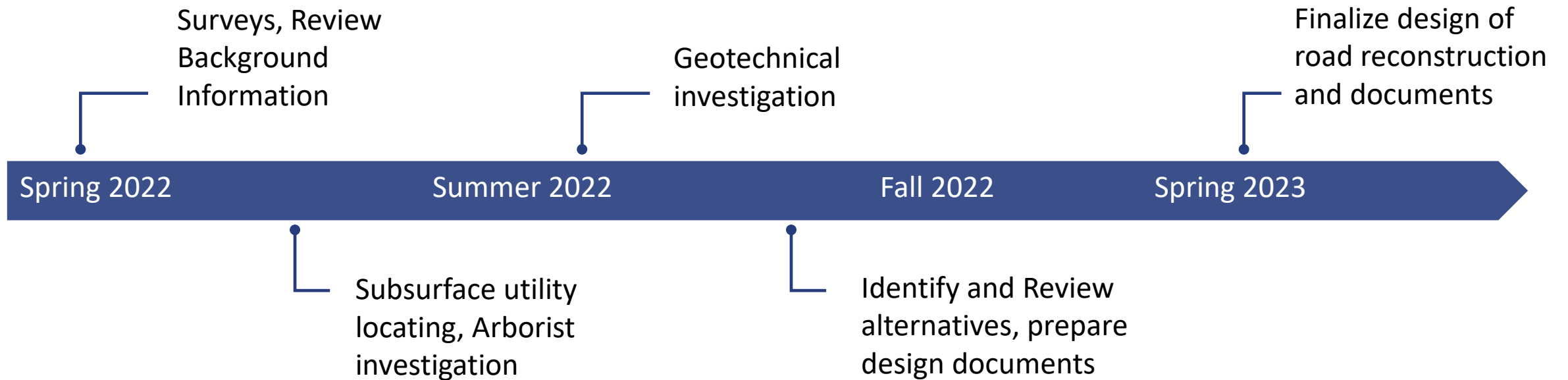
- High groundwater table due to proximity to lake
- Flat lands drain slowly
- Underlying peat provides poor structural support
- All contribute to a shorter road lifespan and increased maintenance needs

# Reconstruction of Irving Drive, including:

- Road reconstruction west of Riverview Beach Road resulting in a grade raise of 19cm
- Asphalt repaving east of Riverview Beach Road resulting in a grade raise of 5cm
- Culvert replacements and re-ditching throughout

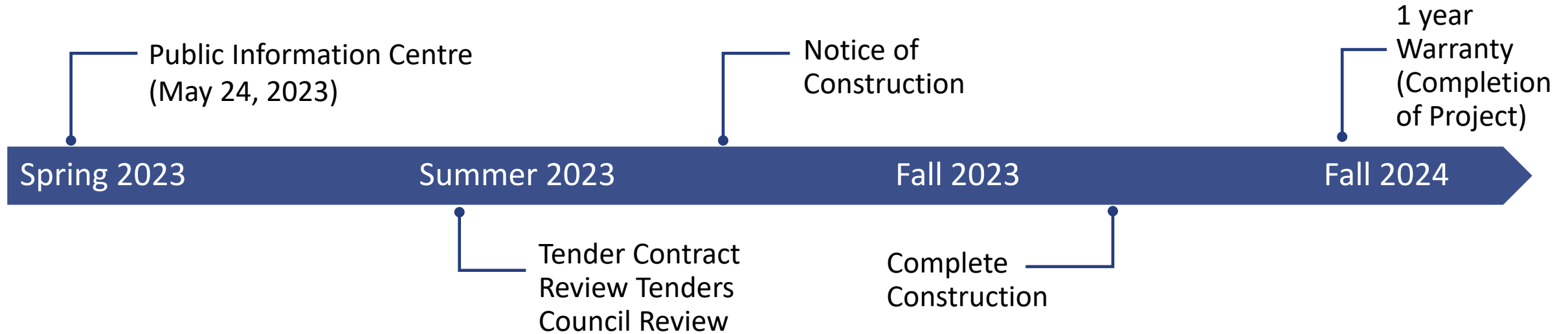


# Construction Impacts:

- For construction worker safety, the road will be signed closed but will remain open to local residents and emergency vehicles at all times
- Short term driveway closures during the day to facilitate construction. You will be notified 24 hours in advance of any disruptions.
- Mailboxes, garbage enclosures, fences, gates and other features may be disturbed but will be reinstated. You will be notified 24 hours in advance of any disruptions.
- Garbage pickup will be organized by the contractor if required due to any disruptions.
- Construction hours will be limited to the Town's Noise By-law being 7am to 8pm Monday to Saturday
- Permission to Enter will be requested in the event that works on private property are necessary to reinstate driveways and ditches
