



Taste of Georgina Contest Rules

February 23 - March 7, 2024

1. Agreement: These rules govern the “Taste of Georgina” contest. The act of entering the contest constitutes acceptance of the contest rules and the decisions of the Economic Development and Tourism office at the Town of Georgina, which decision shall be final and binding on all entrants.
 2. Eligibility: The contest is open to all participants that have reached the age of majority, except for the Town of Georgina employees, their immediate families, and anyone living with any employee of the Town. Incomplete or illegible entries will not be accepted and will be disqualified.
 3. Campaign: Enter the contest by collecting stamps from any Taste of Georgina participating restaurant by purchasing a special prix fixe menu between 12:01 a.m. on Feb. 23, 2022, and 11:59 p.m. on Mar 7, 2024 and submitting the stamp passport to the Town of Georgina by March 15, 2024. Each stamp collected counts as one eligible ballot into the contest. Participants are required to complete the information section of the stamp passport and email a photo of it to tourism@georgina.ca or deliver the passport to the Town of Georgina Civic Centre at 26557 Civic Centre Rd before March 15, 2024 to enter the contest. Four winners will be chosen by random draw to receive one of four prizes (one of three \$100 gift cards to any Taste of Georgina participating restaurant or one set of ROC day passes for the 2024/2025 season). The winners will be contacted by the phone number or email provided on the stamp passport by a representative of the Georgina Economic Development and Tourism office and must reply within 48 hours to maintain eligibility. If the winner cannot be contacted within this time period or fails to respond to any attempted contact, such potential winner will be disqualified, his/her entry will be declared null and void and the Town reserves the right, in their sole and absolute discretion, to select at random another eligible entry, in which event these provisions shall apply to such other eligible entry.
 4. Prizes: Three (3) winners will receive one \$100 gift certificate each to a participating Taste of Georgina restaurant of their choosing. One (1) winner will receive two (2) all day passes to the ROC valid for the 2024/2025 season.
 5. Release: Prior to receiving the prize, the winner will be required to show a valid photo ID and to sign a declaration of eligibility form releasing the Town of Georgina from any and all liability in connection with the contest and or the prize, confirming compliance with the rules and consenting to the use of his or her name testimonial, photograph or video, in any and all forms of media, without further compensation, in any publicity carried out by the Town of Georgina.

9. Other: Odds of winning depend on the number of eligible entries received. This contest is governed by the laws of Ontario and the laws of Canada applicable therein and is void where prohibited by law. The Town of Georgina reserves the right to cancel or modify the contest rules at any time without notice. All prizes must be accepted as awarded, are non-transferable and are not convertible to cash. All prizes are awarded as-is and no warranties or guarantees are implied or expressed, beyond the standard manufacturer's warranty. The Town of Georgina is not liable for any lost, late, misdirected or stolen entries or inability to process entries, or any errors, damage or negligence that may arise in connection with this contest, including technical failures on the part of contest software, virus, website down-time, human error or property damage incurred by any contest entrant.
