## **Georgina Town Council May 7**

### **Verbal report and presentation by staff providing Bylaw Investigations Map**

Council received the verbal update and presentation regarding the Bylaw Investigations Map. It shows where Municipal Law Enforcement has investigations underway. Council directed staff to use the map for internal purposes only at this time. Staff will report back to Council at a later date.

### **Commemoration of the Old Shiloh Bridge**

Council received the report regarding the commemoration of the Old Shiloh Bridge. Council approved funding of up to \$15,000 for the commemoration which includes a shadow box display containing images, artifacts and write-ups of its history, as well as installation of commemorative plaques at the new replacement bridge, and to publicly procure a piece of art commemorating the bridge, all to be funded from the Tax Rate Stabilization Reserve.

### **Traffic control and parking request work plan update**

Council received the report on the traffic control and parking request work plan update. Council adopted Bylaw 2025-0034 (TR-1) and 2025-0033 (TR-1) to regulate traffic and control the parking of vehicles, and Bylaw 2025-0035 (REG-1) to regulate the Town of Georgina Administrative Penalty and Fees. The development of the Safe Streets Policy has ensured timely action on requests and enhanced staff responsiveness. Since May 2024, staff have conducted a review of 73 traffic-related inquiries. Current traffic calming programs will build on efforts to address speeding concerns throughout Georgina.

### **Proposed site alteration agreement**

Council received the report regarding the execution of a proposed site alteration agreement for the Baldwin Airport. Council directed the Director of Development Services to execute the agreement between the Town and the owner, 2686570 Ontario Inc. o/s IPCF Baldwin Airport.

### **Town of Georgina Housing Needs Assessment**

Council received and endorsed the report regarding the Housing Needs Assessment. The findings in the report will be considered by the Town as factors in the decision-making process on future development applications, implementation of the Housing Action Plan and projects including reviews of the Official Plan/Secondary Plans, the Comprehensive Zoning Bylaw, the Servicing Allocation Assignment Program, the Development Charges Bylaw and the Development Services Fee Bylaw. The Housing Needs Assessment will be sent to the Association of Municipalities of Ontario (AMO) and Canada Mortgage and Housing Corporation

in fulfillment of conditions for funding through the Canada Community-Building Fund and the Housing Accelerator Fund.

### **2025 construction season update**

Council received the briefing note on the 2025 construction season update. The Town provides information for its planned construction activities on the [capital projects map](#) on the website. The briefing note included a [line-by-line description](#) of the work scheduled for 2025 and the potential impacts.

### **Closed session**

In regard to Closed Session Item 17.1.a under Section 239 (2) (c) of the Municipal Act being a proposed or pending acquisition or disposition of land by the municipality or local board regarding potential property disposition, Sutton,

That Council receive the update and that staff be directed to proceed accordingly.
