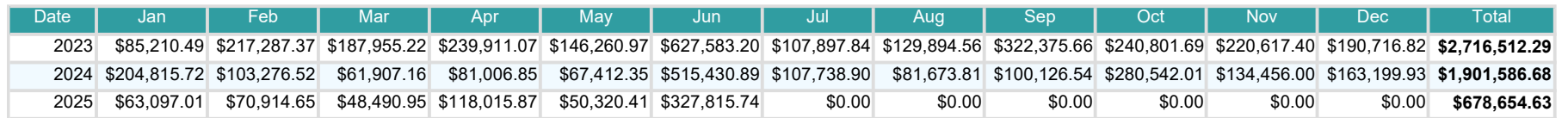
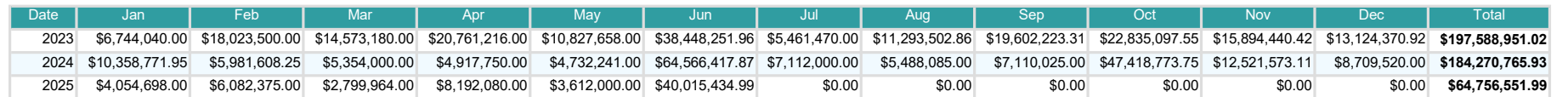


### Permit Fees Collected for Issued Permits by Month

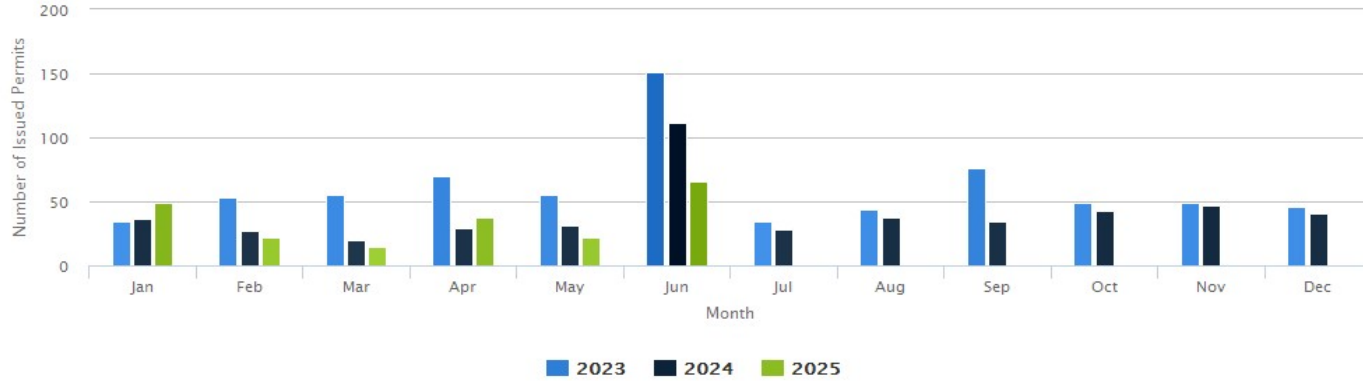


### Construction Value of Issued Permits by Month
