### **Verbal update on Replacement Civic Centre**

Council received the verbal update regarding the Replacement Civic Centre. The project is progressing well, with significant activity underway inside the building with some of the remaining main systems being commissioned and final furniture and equipment being installed. Staff will move in during February, with careful attention to business continuity, including the phased transfer of IT and software systems to ensure uninterrupted public service. In the spring, dependent on the weather, fill material will be brought in, landscaping will proceed and paving will be completed. Demolition of the current Civic Centre building is scheduled to take place in stages during the months of March through May. The project remains on time and within budget.

### **Results of the Request for Expression of Interest (REOI) – Affordable Housing**

Council received the report regarding the results of the Request for Expression of Interest (REOI) – Affordable Housing. Council authorized staff to enter into a Contribution Agreement between the Town of Georgina and Housing York Inc. for the purpose of building affordable housing in Georgina. The project, located at 187–195 The Queensway South, will feature a five-storey building with 86 units, including 50 affordable housing units (32 community housing and 18 transitional housing) and 36 emergency housing units, along with 8,000 sq. ft. of multi-purpose community space.

### **Automated Speed Enforcement (ASE) Program Conclusion**

Council received the report regarding the conclusion of the Automated Speed Enforcement (ASE) program. Council endorsed the use of the \$255,036 Road Safety Initiative Fund (RSIF) to engineering, enforcement and education improvements at former, current or planned ASE sites, in accordance with the guidance from the Province.
