



Notice of Statutory public meeting to consider changes to building permit fees, planning fees and development engineering fees

Take notice that Town of Georgina Council is holding a public meeting on May 6, 2026 at 9 a.m. to discuss proposed changes to Building Permit Fees, Planning Fees and Development Engineering Fees. Council will be considering the approval of the updated development fee bylaw on a date following this public meeting.

The primary purpose of the public meeting is to obtain public comments on the proposed changes to the Town of Georgina's existing building permit fees and is being held pursuant to Section 7(6) of the Building Code Act, 1992. The public meeting will also include a discussion on the proposed fees for planning and development engineering applications, as it relates to applications processed under the Planning Act and the Municipal Act, respectively. The intent is to ensure that development fees charged by the Town's Development Services Department accurately depict the full cost of service delivery.

The Development Fee Study will be made available on at georgina.ca/PublicNotices on or before April 15, 2026. The proposed development fee bylaw will not be considered by Council at this meeting. The bylaw will be considered by Council at a future meeting, after considering comments received as part of the public meeting and the consultation process.

Any person may attend the public meeting and make written or verbal representation either in support of or in opposition to the proposed fee changes.

If you wish to be notified of the adoption of the proposed fee changes, you must make a written request to the Clerks Division at the address noted below. All comments and questions should be sent by 5 p.m. on April 26, 2026. Comments received before and at the public meeting will be considered by Council before making any changes to the development fee bylaw.
