Beaches and waterfront parks

Georgina's beaches and waterfront parks are open. Barbecues and other cooking devices are not allowed on the beach or in the parks. Visit georgina.ca/beaches for more. Parking lots are available to both resident parking pass holders and non-residents. Residents must have a 2021 resident parking pass to park for free in the resident parking lot. For those without a pass, pay-and-display machines are operating. To get a parking pass, visit georgina.ca/ParkingPass. Georgina residents can get a 2021 parking pass on site at De La Salle Beach, Holmes Point and Willow Beach, from 8 a.m. to 8 p.m. daily. Residents will need to show their driver's licence, or proof of residency, and provide their licence plate number. Only one parking pass will be issued per vehicle on site.



Georgina COVID-19 vaccination clinic

The York Region COVID-19 vaccination clinic located at the Georgina Ice Palace, 90 Wexford Dr., will be closing on Aug. 22. Rather than operating these mass COVID-19 vaccination clinics, York Region Public Health is beginning to transition to smaller mobile and pop-up clinic models. Until Aug. 22, the clinic will accept walk-ins for both first and second doses for all eligible individuals who live, work or go to school in York Region. 

Fire and Rescue Services

Did you know? Electrical fires are one of the top three causes of fires in Georgina. We need to be cautious and keep safety in mind. Georgina Fire and Rescue Services has some tips to keep you safe:

- Have all electrical work done by a qualified electrician.
- When buying or remodeling a home, have it inspected by a qualified private inspector or in accordance with local requirements.
- Only use one heat-producing appliance (such as a coffee maker or toaster) plugged into a receptacle outlet at a time.
- Major appliances should be plugged directly into a wall receptacle outlet. Extension cords and plug strips should not be used.
- Use ground-fault circuit interrupters to reduce the risk of shock.
- Check electrical cords to make sure they are not running across doorways or under car pets.
- Use a light bulb with the right number of watts.
- Make sure any overhead lines maintain the proper distance over a pool and other structures.
- If you are putting in a new pool, hot tub or spa, be sure the wiring is performed by an electrician experienced in the special safety requirements for these types of installations.
- Electrical appliances, equipment and cords should be kept at least six feet away from the water.
- Replace or repair damaged or loose electrical cords
- Avoid overloading outlets.
- Maintain a three metre 'no storage' area around electrical panels.

Burn permits

Permit applications for agricultural and open-air burn permits are available online. The permit fee is \$35. Residents can have recreational fires to roast marshmallows and hot dogs, and these fires do not require a permit. They must be no larger than 2' x 2' and be at least 23' away from anything that can burn as well as property lines. Visit georgina.ca/BurnPermit to learn more.


