Beaches, waterfront parks and outdoor recreation amenities

Waterfront parks and beaches are open daily from 8 a.m. to 8 p.m. with restrictions. Town staff are on site to monitor and control the number of users permitted in the parks. Parking lots are currently available to resident pass holders only. In order to limit crowds at these locations, available parking spaces have been reduced. Once parking lots reach capacity, the parking lots will be closed. Residents will be required to display their 2021 resident parking pass to park in the lots. For those who have yet to obtain one, 2020 passes will be accepted. Visit <u>georgina.ca/beaches</u> for information on the restrictions.

Outdoor recreation amenities have also reopened. This includes tennis/pickleball courts, basketball courts, sports fields, skateboard parks, soccer fields and baseball diamonds. Residents are reminded of provincial guidelines when using any amenities.

Notice to property owner to destroy noxious weeds

Notice is hereby given to all persons in possession of land in accordance with the Weed Control Act, R.S.O. 1990, c.W.5, Sections 3, 16 and 23. Every person is hereby advised that unless noxious weeds growing on their lands within the Town of Georgina, in the Regional Municipality of York are destroyed prior to June 15 and throughout the season thereafter, the weed inspector may enter upon said lands and take such action as is necessary to destroy the weeds. All costs incurred for such action shall be charged against the lands and such amounts shall be collected in the same manner as property taxes as specified in the Municipal Act, 2001 as amended.

Notice of passing of Development Charges By-law by the Town of Georgina

Take notice that the Council of the Town of Georgina passed Development Charges By-law 2021-0041 (AD-5) on May 19, 2021, under Section 2 of the Development Charges Act, 1997.

And take notice that any person or organization may appeal to the Local Planning Appeal Tribunal (LPAT) under section 14 of the Act, in respect of the Development Charges By-Law, by filing with the Clerk of The Town of Georgina on or before Monday, June 28, 2021, a notice of appeal setting out the objection to the By-law and the reasons supporting the objection. Appeals filed with the Office of the Clerk at 26557 Civic Centre Road, Keswick, ON L4P 3G1, will be accepted on or before Monday, June 28, 2021. Due to the COVID-19 restrictions, the appeal filed may also be accepted if placed in the Town's drop box on or before Monday, June 28, 2021. A fee is applicable with the appeal application. The appellant is advised to contact LPAT to access the required forms and applicable Provincial fees.

The charges in the aforementioned by-law will apply to all new residential and non-residential development, subject to certain terms, conditions and limited exemptions as identified therein.

Development Charges By-law Number 2021-0041 (AD-5)

Town-wide development charges are levied against new development to pay for the increased capital costs related to the provision of such town services as Library Services, Fire and Rescue Services, Services Related to a Highway (Road Operations, Roads and Related Services), Development Related Studies and Stormwater Services.

Furthermore, the by-law establishes the development charges for the Keswick, Sutton, Sutton High Street Sewer and Queensway East and West service areas of the Town and the development charges are only applicable to development occurring within the area outlined in Schedule 2.

The services related to the Keswick and Sutton service areas relate to services related to a highway, water, sewer and development related studies. Services related to Sutton High Street sewer relate to sewer services. Finally, services related to the Queensway East and West service area relate to water services and development related studies.

The development charges are calculated on a "per unit" basis for residential development and on a "square metre" basis for non-residential development. Schedule 1 below sets out the development charge rates applicable throughout the Town of Georgina. A key map has not been provided as the Town-wide charges apply to all lands located within the boundaries of the Town of Georgina. Schedule 2 below sets out the area-specific development charge rates applicable in the Keswick, Sutton, Sutton High Street Sewer and Queensway East and West service areas with key maps also provided.

The development charges imposed under the By-law came into effect on the 19th day of May 2021. Copies of the complete Development Charges By-law is available for examination

at georgina.ca/DevelopmentCharges.

Upon reopening of municipal offices from the COVID-19 restrictions, copies will also be available during regular business hours (weekdays from 8:30 a.m. to 4:30 p.m.) in the offices of the Town located at 26557 Civic Centre Road, Keswick, ON L4P 3G1. Key maps are not set out in this notice as the details and scale of such maps would be difficult to reproduce in an accurate and legible form.
