Canada Day

The Town of Georgina wishes everyone a Happy Canada Day! Customer service will not be available on Thursday, July 1 or Friday, July 2.

Waste and recycling

Due to the Canada Day holiday, yard waste pickup for that day will move to Friday, July 2.

Fireworks

Residents are reminded they can set off fireworks without a licence on Victoria Day and Canada Day only, as well as the day before and after each of these holidays. A licence is needed to set off fireworks on any other day of the year. Remember to carefully read and follow the label directions on fireworks' packaging. It is against the Town's by-law to set off fireworks in Town parks/amenities. Remember to follow the COVID-19 provincial guidelines regarding Step 1 of the province's roadmap to reopen. Outdoor gatherings are to be limited to 10 people. For more visit georgina.ca/fireworks.

Beaches and waterfront parks

Coinciding with the province's reopening plan, the Town has taken the next step in opening its waterfront parks. Parking lots are available to both resident parking pass holders and non-residents. To park in the resident parking lot, a 2021 parking pass is required. To date, 2020 parking passes have been accepted. Starting July 1, residents must have a 2021 resident parking pass to park for free in the resident parking lot. For those without a pass, pay-and-display machines are operating. To apply for a parking pass visit georgina.ca/ParkingPass. In order to limit crowds at these locations, available parking spaces have been reduced. Once parking lots reach capacity, they will be closed.

Georgina residents can now get a 2021 parking pass on site at De La Salle Beach, Holmes Point and Willow Beach, from 8 a.m. to 8 p.m. daily. Residents will need to show their driver's licence, or proof of residency, and provide their licence plate number. Only one parking pass will be issued per vehicle on site. Georgina COVID-19 vaccination clinic

The vaccination clinic is located at the Georgina Ice Palace, 90 Wexford Dr. As of June 14, eligible individuals who live, work or attend school in York Region who received their first dose on or before May 9, and who already have a second dose appointment booked, now have the option to re-book an earlier appointment. A Zoning By-law amendment application has been submitted by Michael Smith Planning Consultants; Development Coordinators Ltd; on behalf of 1750582 Ontario Inc. (Justin Risi and Vivian Risi), 2065194 Ontario Inc. (Jeanette Sarni), New Building Blocks Inc. (Justin Risi & Vivian Risi), and SB Developments Inc. (Domenic Sorbara) to rezone a portion of subject properties from 'site-specific General Commercial (C1-1)' and 'Low-density Urban Residential (R1)' to 'site-specific Medium-density Urban Residential (R3-XX)'. The purpose of the application is to facilitate the construction of an 84-unit, rental-tenure, apartment dwelling.
