Daylight Saving Time

It's almost time to spring forward! The clocks go ahead one hour at 2 a.m. on Sunday, March 14 as we make the change to Daylight Saving Time. As you change your clocks, remember to change the batteries in your smoke and CO alarms. In order to survive a fire, you need to be provided with an early warning and know what to do when the smoke alarms sound. Working smoke alarms are required on every storey in a home and outside all sleeping areas. For added protection, it is recommended to also install smoke alarms inside all bedrooms. Load restrictions on Town roads

March 1 to May 15

Every spring, between March 1 and May 15, there is a load restriction to five tons per axle on Town roads. The reason for the load restriction is that with the warmer weather, the roads become soft, and vehicles travelling with loads larger than the limit could potentially cause damage. Georgina COVID-19 vaccination clinic

Vaccines have arrived in Georgina. Everyone who wants one, will get one. The vaccination clinic is located at the Georgina Ice Palace, 90 Wexford Dr.

- **Vaccines for eligible individuals** – high priority health care workers who live or work in York Region, and residents who are 80 years of age and older – are delivered by appointment only. Walk-in appointments are not available. Appointment bookings can be made at york.ca/covid19vaccine. As more vaccine supplies become available, more clinics and appointments will be opened up to immunize residents.
- **The online booking process requires two steps** – first create an Active Net account if you don't have one and then book an appointment. You must complete both steps to be fully registered for an appointment, and will receive a confirmation email with your appointment date and time.
- Some residents who are not able or not comfortable booking an online appointment are encouraged to seek out a support person (caregiver, family member, friend or neighbour) who can assist in booking an appointment. If you need assistance booking, call **1-877-464-9675**.

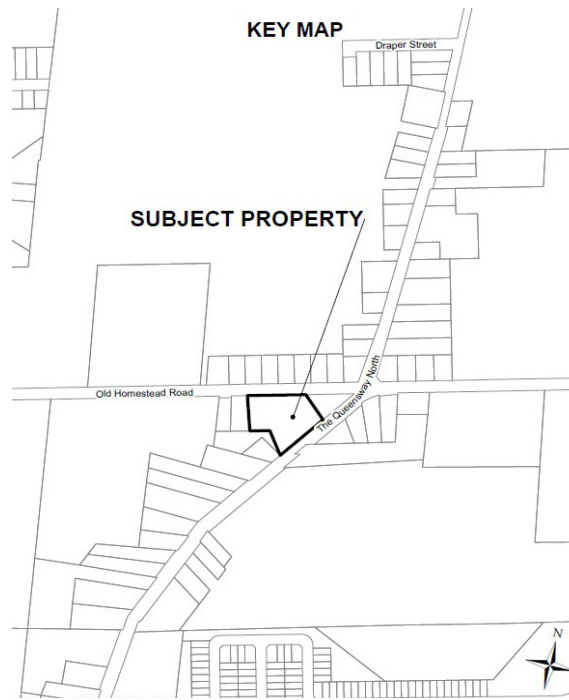

Public Notice of Intent Public Notice of Intention to Designate A Heritage Property

In the matter of the Ontario Heritage Act, R.S.O. 1990, Chapter 18, section 29 (3);

And in the matter of the lands and premises known as the Johnston Cemetery located within a property known as 264 Pefferlaw Road, Pefferlaw, Ontario (the "Property"). The Property is legally described as PIN 03538-0356 (LT), being part of Lot 22, Concession 5 Georgina, as in R571809, Georgina. The part of the Property on which the Johnston Cemetery is located is legally described as Part 5 on Reference Plan 65R-16564.

Take notice that the Council of the Corporation of the Town of Georgina intends to designate the following property for reasons of cultural heritage value or interest:

Legal Description of the Property to be Designated: Johnston (Johnson) Cemetery Part 5 on Reference Plan 65R-16564.

Statement of Cultural Heritage Value: The interments in the Johnston (Johnson) Cemetery ("the Cemetery") include the earliest pioneers of Pefferlaw in the Township of Georgina. The Johnston (Johnson) Cemetery was a burying ground between 1860 and the mid-1950s and was originally located on the southwest corner of Robert Johnston's farm. Its presence for over 160 years indicates that it is important in defining the character of the area and that it is linked in all senses to its surroundings. It sits as a landmark on the main street in the Village of Pefferlaw.
