Georgina COVID-19 vaccination clinic

Vaccines have arrived in Georgina. Everyone who wants one, will get one. The vaccination clinic is located at the Georgina Ice Palace, 90 Wexford Dr.

- **Vaccines for eligible individuals** – high priority health care workers and other frontline health care workers who live or work in York Region, and residents who are 80 years of age and older – are delivered by appointment only.
- **The online booking process requires two steps** – first create an Active Net account if you don't have one and then book an appointment. You must complete both steps to be fully registered for an appointment, and will receive a confirmation email with your appointment date and time.
- Some residents who are not able or not comfortable booking an online appointment are encouraged to seek out a support person (caregiver, family member, friend or neighbour) who can assist in booking an appointment. If you need assistance booking, call **1-877-464-9675**.



A Zoning By-law amendment application has been submitted by Ali Korangi on behalf of Ali Korangi and Tayebah Rezvanirad to rezone the subject property from 'site-specific restricted industrial (M1-4)' to 'site-specific low-density urban residential (R1-XX)'. The purpose of the application is to facilitate the conversion of the existing industrial building into a single detached dwelling with an accessory apartment.
