Georgina COVID-19 vaccination clinic

The vaccination clinic is located at the Georgina Ice Palace, 90 Wexford Dr. On Tuesday, May 4, 2021, the immunization area at the Georgina Ice Palace COVID-19 vaccination clinic will be moving to a new area at the back of the facility. The entrance, exit and client parking for the clinic will now be at the north side of the building. This is an accessible entrance.

The online booking process requires two steps – first create an Active Net account if you don't have one and then book an appointment. No parking/stopping fines increase

The Town is increasing no parking and no stopping fines in the Waterfront Park Buffer Zone in an effort to reduce illegal parking and stopping in waterfront areas. The Waterfront Buffer Zone includes the entire shoreline area of Lake Simcoe and Town roads in lakeside neighbourhoods. A section along the Black River north of High Street in Sutton is also included. No parking fines will increase from \$30 to \$100 and no stopping fines will increase from \$50 to \$150. Enforcement begins on May 22, the Victoria Day long weekend. The fines apply to all motorists only in the event they are parked or stopped in restricted areas within the Waterfront Park Buffer Zone.

Burn permits

Permit applications for agricultural and open-air burn permits are available online. The permit fee is \$35 for the calendar year. Residents can have recreational fires to roast marshmallows and hot dogs, and these fires do not require a permit. They must be no larger than 2' x 2' and be at least 23' away from anything that can burn as well as property lines.

Residential Decks, each – \$160 Residential sheds and garages –

- One storey less than 592 square feet \$160
- Others \$0.55 per square foot
