Parking passes

The Town of Georgina has introduced a new online process for resident parking passes. Residents and property owners can now apply online and get a parking pass immediately. Residents can obtain up to a maximum of four parking passes per household. A parking pass must be displayed on your dashboard while parked in areas where required by signage. Water and sewer rates

The revised 2022 water and sewer rates were adopted by Council on Dec. 1, 2021. The rate change represents a 5.84 per cent increase when factoring in both metered and capital charges over 2021 rates and is in effect for billings as of April 1. This increase ensures revenue is provided for the operating expenditures for the water and sewer systems. In addition to the metered consumption rate, a capital cost recovery fee of \$21.94 is included with each water and sewer bill. This fee is set aside for future capital expenditures for both the water and sewer systems. Learn more at georgina.ca/WaterBilling.

Sod damage

Sidewalk plowing presented challenges throughout the winter as it is difficult to tell where the edge of the sidewalk is. When the ground is not frozen some sod damage may occur. Damage to Town sod, pavement and Town-owned trees will be repaired in the spring. The cost of both the sod and repairs is built into the Town's contract. Emerald Ash Borer tree removal program

The Town of Georgina has been infested with the Emerald Ash Borer for a number of years and virtually all mature Ash trees are affected. The Town has taken many preventative steps including creating an inventory of Ash trees, conducting regular health assessments, and performing thousands of removals of dead or dying trees. This tree removal program is being expanded to accelerate the removals. The new program will remove all affected trees on municipal property within the Town over a three-year period, 2022 to 2024. 2022 Mosquito program notice of ground and aerial larvicide application for the control of larval mosquitoes for nuisance control

From April 3 to May 31, GDG Environnement Ltée. will apply a biological larvicide by air and ground to stagnant water to control larval mosquitoes that impact the residents in Georgina, east of Weirs Sideroad. The applications are weather dependent and are likely to occur closer to April 15. The program will use multiple applications of the biological larvicides VectoBac 200G (PCP #18158, granular) and VectoBac 1200L (PCP #21062, liquid). The granular will be applied by helicopter and the liquid by backpack applicators. The treatment area map and program details are available at georgina.ca/mosquito.
