- 10.1.2.3 The Link Coordinator requests position be filled prior to completion of construction.
  - Link Coordinator would like position filled because the vacancy is a position that represents members of public.

  - Requires daytime availability. None of the applicants from the existing pool indicated daytime availability.
  - Consider for advertisement, the committee stands only until construction of Link is complete.
