Regular update by Scott Edwards if available.
 - A. Ravencrest Reports

Scott Edwards advised that Ravencrest has been receiving complaints again, people are going roughly 20 over the speed limit. Mike Roots advised YRP has attended 32 times and issued 49 tickets in this area. Ravencrest is being used as a cut through.

Nelson Costa discussed alternative options for areas of concern s. Mr. Costa suggested there may be an opportunity for the Region to assist with line painting Town roads as the Region has the equipment, the Town would need to cover the costs. The Committee was advised they have also had success with moving speed boards around rather than keeping them in one spot.

The Committee was also advised that speed limits are based on guidelines

from Transportation Canada. It is not recommended the same road vary in speed limits, but also limits should match characteristics of the roadway (Urban, Fringe, & Rural).

The Committee was also advised Collisions that are happening as a result of speeding are less than 5% on regional roads.

Dear Mr. Fellini,

My family and myself live on Shorecrest Road right beside Lakeside Public School. My 2 children attend this school and we love our neighbourhood and our neighbours. Our neighbours and I have a very serious concern about the speed of cars coming and going from Lakeside Public School at drop off and pick up. There have been many occasions my husband or I have had to raise our voice to tell drivers to slow down. We have to walk our children across the road to the sidewalk to get to school. There have been times I have had to push my children back because the cars are driving way too fast and then raise my voice to ask the driver to slow down. There has never been a police presence on our street to monitor the speed of the traffic and to ensure the safety of the children coming and going from the school. The reason there is no police presence, is that our street is not marked as a community safety zone. There is not one sign posted, except for the speed limit of 40km's which is far too fast and a no exit sign. I have spoken to the school about this and they did put it in their weekly newsletter, but nothing changed. Something needs to be done and done soon before some gets hurt, especially now that the weather is getting nicer. My neighbours and I would like to invite you one morning to stand with us and watch the cars coming and going from

the school during drop off, you would be very enlightened and disgusted.

I made a few adjustments to the article.

The Georgina Agricultural Advisory Committee would like to remind the residents of Georgina that the local farmers will be moving their tractors and equipment along the roadways as they prepare for the 2017 crop season.

Please be patient if you are caught behind them as they cannot do the same speed as cars and trucks. Some agricultural equipment is wide and takes up more space on the roadway. Farmers do their best to keep to the right of the centre line but sometimes the shoulders aren't safe to travel on and they have to take up space in the opposite lane. When the tractor operator is making a right hand turn into a lane way or field entrance, they often have make a wide turn, meaning they will move into the left lane and turn back across the right lane. Never try to pass them on the right. Please be aware when traveling over a hill that there may be a slow moving vehicle on the other side.

Watch for the unique slow moving vehicle sign that will be displayed on the back of the tractor and equipment. Not all farm equipment have brake lights or turn signals so you'll need to watch for hand signals indicating a turn is being made.

We thank you for your cooperation in sharing the roads with the farmers.

York police on a bus: "Put down that phone"

- In 2016, York Region police laid 4,586 charges for distracted driving.
- So far this year, police have seen a 69 per cent increase in charges from this time last year.
- Following the success in York Region, Toronto police are now exploring the idea of enacting the program south of Steeles Avenue.
- Anything can be a distraction, from your snack behind the wheel to kids in the back seat (one bus driver told police he witnessed a woman breastfeeding her child while behind the wheel).
- You don't have to be tapping on your phone or speaking into it — it doesn't even need to be turned on. If the phone is in your hand, you can be charged whether the vehicle is moving or stopped at a traffic light.
- Consequences are especially harsh for novice drivers; for those convicted under age 22 with a G2 license, the ministry may suspend licenses for 30 days.
- Male and female seem to offend equally, but most are younger than 55.

Ever feel like you're being watched?

You should, because you are.

York Regional Police wants you to know that officers have their eyes on you when you're on the road — and even when you think you can't be seen, they see.

That little trick you do, when you tap at your cellphone between your knees, below the steering wheel?

They're onto you.

Hiding the phone under your thigh?

They're onto that, too, and you can thank public transit buses, towering above your car in the next lane, for revealing your secret.

York police' new campaign "We're on board; are you?" was launched this week with a unique "bus ride-along".

Media was invited to tag along April 13 aboard one of their newly-"wrapped" buses displaying the image of a YRP officer leaning out the window, writing a ticket.

It's a not-so-subtle reminder that police are peering down at you from York Region buses and if you want to avoid a hefty fine, you best put down that phone.

York Regional Police Traffic Enforcement Unit, in conjunction with York Region Transit, launched the campaign this week to fight distracted driving.

The offence — use of cellphones in particular — remains a significant safety concern for drivers and pedestrians, according to traffic bureau Insp. Randy Slade.

Since January, the YRP has been riding public transit to watch for drivers using their cellphones or other hand-held devices, then relaying the information to officers patrolling the roadways.

Now they've added the "bus wraps", depicting a police officer leaning out of the bus window, on five transit vehicles travelling throughout the region.

The campaign is two-pronged: while drivers are nabbed for using their devices, bus passengers see first-hand just how dangerous the roads can be for them as pedestrians.

Those same passengers are often eager to help police by looking for offenders from their own bus seats and sharing with the police officer on board.

Members of the media joined police Friday as they nabbed distracted drivers while peering out the windows of public transit buses. April 13, 2017

It didn't take long for the reporters, photographers and camera operators to get into the spirit of things during Friday's ride-along.

As the bus travelled south on Yonge Street to Highway 7, Sgt. Aaron Sidenberg immediately spotted two drivers surreptitiously tapping on their phones. He communicated the info via radio to nearby unmarked police vehicles and within minutes, those drivers were facing \$490 fines and three lost demerit points.

Soon, the ride-along media were joining in, peering into cars ("like an Easter egg hunt for adults", someone joked), pointing out other offenders — a female in a white Cherokee, a man in a beige convertible — and laughing to see how many drivers scrambled to hide the phones beneath their legs when they realized they were caught.

One driver caught with his phone was nabbed for much more: three-times-suspended license, no insurance, on probation and not allowed to drive his car.

A total of five drivers were nabbed in the short trip. Earlier that day, police caught 16 distracted drivers between Yonge and Mulock and Steeles, including one using a full-sized iPad, Sidenberg said.

Buses provide the perfect high vantage point, he said, especially for peering into pickup trucks and cube vans.

"Our message is: put it down," said Slade. "There is nothing that important that can't wait until you get to your destination."
