Salty trend may cause long-term damage to Lake Simcoe watershed: LSRCA

Chloride concentration in the lake increasing by about .7 milligrams per litre annually since 1971

For decades, salt has been the standard "go-to" for winter maintenance in the Lake Simcoe watershed.

But excessive winter salt usage, both by municipalities and private businesses, has caused the average chloride concentration in the lake to increase by about .7 milligrams per litre annually since 1971.

At this rate, the lake will exceed the Canadian government's chronic (long-term) chloride guidelines by 2120.

While that seems like a long way off, reductions in usage take time and there's little indication the increase is slowing, said Bill Thompson, the Lake Simcoe Region Conservation Authority's manager of integrated watershed management.

"There's really no change," he said. "The challenge with salt is it's pretty much invisible. You put it down and it disappears. The more people that are aware there's an environmental impact, the more people will think twice before demanding that level of service from their local store or municipality. Their behaviour impacts the health of the watershed."

About 100,000 tons of salt is applied to paved surfaces within the watershed each year. Much of that ends up in creeks and rivers before getting to the lake.

The LSRCA monitors chloride levels at 21 tributary locations and 17 lake stations.

Data show chronic guidelines are already exceeded in many creeks and rivers in Barrie, Newmarket and Aurora and that the issue is mostly caused by the larger urban municipalities around the lake.

"We look to not over-apply any de-icing materials on roadways and sidewalks," Newmarket infrastructure services commissioner Peter Noehammer said. "That's carefully measured."

Periodic sampling over a five-year period has also recorded 17 cases of acute (short-term) guideline exceedances at Hotchkiss Creek in Barrie, and 44 at Holland Landing over one winter.

Barrie has been working to reduce salt usage through resident education and outreach and a spring street sweeping program that prioritizes clean-up near sensitive areas like creeks. However, each municipality has to balance safety and liability concerns with environmental protection.

"We still need to make sure we provide a safe transportation network so the community and businesses can all function in the winter," Barrie risk management official Katie Thompson said.

"It is a challenge. As we get the amount of salt down, we're always adding new roads which bump the numbers back up again. The solution is going to have to be collaborative; it's going to take the provincial government, municipalities, residents, businesses and conservation authorities all working together to improve our practices."

Some insect populations in tributaries are already showing damage, Bill said.

"The operational guys can tighten up their practices, then we build another kilometre of road that we need to maintain," Bill said. "We're fighting against ourselves, unfortunately."

Residents can take steps to help their municipalities reduce reliance on salt, such as wearing boots with good traction and putting snow tires on their vehicles.

Municipalities can also encourage the construction of low-impact developments and parking lots and businesses should participate in the LSRCA's Smart About Salt training and certification program, to learn best usage practices, Bill said.



Jackson's Point residents petition against redevelopment of public park

Bonnie Park is not for sale or swap.

That is the sentiment of a group of concerned Jackson's Point residents who launched an online petition —<u>bonnieparkisnotforsale.com</u> — this week stating the historic public park or any portion thereof should not be used as a "bargaining chip" with developers under any harbour redevelopment master plan.

A 16-week, \$90,000 process with The Planning Partnership at its helm was approved by council last week in reaction to the sale of Bonnie Boats earlier this month.

With the town-owned property situated between the Ramada Inn on one side and the former marine property now owned by MSR Holdings Inc. on the other, the town contends a redevelopment strategy with all interested parties involved and six opportunities for public input will allow it to "drive the bus" when it comes to any future development proposals.

Paul Brady, however, is one of many who doesn't agree and thinks there is still time to turn the ship around before one of few remaining public access sites to Lake Simcoe is sunk.

"The town thinks it is a good thing to use a historic public lake access park as a bargaining chip, but we think the plan shouldn't have been set up in the first place," Brady said, adding the \$90,000 would have been better spent cleaning debris off the park, filling in low areas, replacing rotten boards on the dock and a fresh coat of paint on the picnic shelters.

"If an entity has bought a marina, and it turns out that the land can only be used as a marina, then they have a marina," he added. "If that entity can change it into what they want to do, more power to them, but it must be done under the same parameters and guidelines that everyone else must adhere to on their own property ... Bonnie Park is not for sale. Period. It belongs to the people, not just the residents of Georgina, but to all who want to use it."

Wayne Phillips agrees and hopes the petition will prompt people to get involved, make an informed decision and let elected officials know where they stand on the issue.

"I think we're all smart enough to understand that change is going to happen and that we want to be collaborative with the process, but there is a feeling that there hasn't been full disclosure up to this point," Phillips said, echoing the sentiments of Cliff Williams and bait and tackle shop owner Donna Parsons, who were among those upset over unauthorized testing in the park conducted earlier this month and the fact redevelopment proposals concerning two private properties are being floated on the taxpayer dime.

While the group behind the petition may be at the "nucleus" of the situation, they point out it is not NIMBYism that is spearheading their cause.

Police are reminding boaters it's imperative to make sure you have a fully charged cell phone and to always make sure someone knows where you are going and when you will be returning.

Natasha Charles Chippewas of Georgina Island First Nation



Virginia Beach Marina (705) 437-2533 is located on the South Side of Georgina Island. The Marina is owned by the Chippewas of Georgina Island First Nation and operated by a management company. The Marina can be identified from the water by the 6000 square foot Business Center that houses a Restaurant (The Boondocks Eatery), retail store (Tobacco Trails) and other office space. When approaching, you will notice a flashing white light where entrance can be gained through the mouth of the man-made harbour that has marker lights for the Aahzaawe ferry travelling to and from Georgina Island on a scheduled basis.

The Marina is a well-lit facility with 113 slips on fixed docks. Transient slips are available when seasonal slips are vacant and visitors are advised to call ahead. Depth at the docks is about six feet. A hydraulic trailer is available to haul boats up to 34 feet with repairs services for both gas and diesel engines on site. Propeller and canvas repairs can be arranged with the Manager.

The Restaurant (The Boondocks Eatery) is a family owned and operated restaurant that specializes in good food with a twist of good times. When travelling the waterway or in the area, be sure to stop by as they will have all of your needs covered during the lunch, dinner and late night hours.

Facilities: Fuel, Restaurant, Convenience Items, Pumpout, 20 Amp Power at Docks, Water (at fuel dock), Propane, Ice, Bait, Launch Ramp, Vehicle Parking, Portable Washroom Facilities, ATM (during retail outlet hours)
