(2) Livestock Emergency Trailers

The Committee was informed York Region offers a course for livestock trailers in emergency situations. The Fire Chief had suggested to Councillor Harding he would look into having staff attend. The Town will have to come up with their own protocols. Council asked for the Chief to report back to Council in a couple months. It was clarified that the course has been adapted from a course involving specialists (people who handle livestock).

Brad Smockum advised that other municipalities in Western Ontario have started training. Brad Smockum informed the Committee he will call the Fire Chief to get an update for the next meeting.

(2) Livestock Transportation proposed laws

Brad Smockum, Committee Chair, advised the article indicates consideration is being given to amending laws to take into account the weight of livestock and the maximum amount of time they can be in the vehicles. The age of the animals would also taken into account; young livestock may be restricted with total distance. The Committee discussed a W5 report which reported that Canada is one of the worst countries for animal transportation. The Committee discussed the stress on animals when loading and unloading versus the stress of longer

travel times. The Committee discussed the impact the new regulations might have on the cost of transportation and correlating impact on the cost of meat.

(3) New cases of Tuberculosis (TB)

It was noted if the Canadian farmers can't claim TB-free cattle it will affect the market value of meat.

(3) Wildlife Management Units WMU Boundaries Map.

Committee members were advised that North or East of the yellow line on the Map are areas that currently a bear hunting season. The Committee suggested

petitioning the province to allow a bear hunting season for municipalities south of Stouffville and east of King.

The Committee also discussed a recent Coyote attack in Alliston. Committee reviewed the map and discussed whether the allowance of hunting had to do with human populations noting those that don't allow bear hunting are more populated (people). The Committee considered that these areas do allow hunting for other animals.

The Committee requested, Sarah Brislin, Committee Service Coordinator, contact the municipalities of Brock, Uxbridge, East Gwillimbury and King to find out what their kill rates are and the total refunds were for 2016.

The Committee discussed the possibility of publicizing the Livestock Kills

The agreement would guarantee the the date of one event annually to reserve the trailer for. The trailer could be booked for other events if it is available. Each time the trailer is used there would be a \$500.00 fee which the event organizer would pay (unless they had someone sponsor the trailer). The fee would cover transporting the trailer, set up and clean up at the end of the event. Council wants to ensure that it will be used and would like to know if the Sutton Fair Board would be interested in it.

Committee member Jim Lockie advised he would ask the Sutton Fair Board. Councillor Harding offered to find out if the date for Sutton fair is available.
