# 6. BUSINESS(A) Wording for the Town of Georgina Pamphlet

With contributions from all members, the following is the wording that the Board has prepared for the pamphlet that is being designed by the Town of Georgina for promoting Cooke's Cemetery:

Cooke's Cemetery in Pefferlaw is an historical community cemetery established in 1889 on land donated by John Johnston. It was affiliated with Cooke's Presbyterian Church later the United Church of Canada. It operated as a cemetery until 1981 and was re-opened as a municipal, non-denominational cemetery in 1993 under the guidance of the Cooke's Cemetery Board.

This serene and tranquil property is appreciated by all who use it. The variety of trees and the well-maintained flower beds, courtesy of the Georgina/Brock Garden Club, instill pride for the eternal resting place of your loved ones.

# (C) Purhase of Work/Garden Shed:

Larry has purchased a shed, 10 feet by 10 feet, from North Sheds at a cost of \$3,708.66 including tax. It is a dark grey and includes some shelving and a ramp.

At the adjournment of this portion of the meeting we will gather at the cemetery at 4:00 p.m. to meet with Chris Shier from Off The Wall Landscaping to determine and advise him of the placement of the shed. Chris will be providing a quote and doing the work to excavate and fill a proper base for the shed.

## (D) Letter to Town re Maintenance Items:

Items to be included in the letter to the Town so that planning can be undertaken to have maintenance work in the cemetery done in the spring:

- removal two dead trees,
- pruning of the hedge and cleaning out dead trees and vines,
- completing the hedge on the north east end and filling in the gaps,
- trimming and pruning trees within the cemetery grounds,
- digging out the roots in the arbour garden,,
- rolling of the grounds to make the property more level for those who have accessibility issues,
- cutting of the grass in the cemetery and outside the fence on a regular basis, and
- ensuring that there is a supply of water until the pump is reconnected following the completion of the new fire hall.

It was suggested that as part of the letter, we thank the Town for continuing to provide continued financial support for our Decoration Day Service.

# 7. OTHER BUSINESS:

## (A) Ontario Association of Funeral Homes -

An email will be sent to Sandra DiPietrantonio at The Town of Georgina to inquire if the Town belongs to the Ontario Association of Funeral Homes as Greg received notice that a training was being held for cemetery administrative workers. The cost of the training is \$230.00 but if The Town or Keswick Cemetery is not a member we would not be eligible to attend.

## 8. Councillor Harding's Report -

Councillor Harding was not able to attend so there is no report.

## **10. COOKE'S CEMETERY PROPERTY:**

The meeting moved to the Cemetery Property at 3:55 p.m. to meet with Chris Shier.

After examining several sites in the Cemetery, it was determined that the shed would be placed at the northwest end of the Cemetery. This information was discussed with Chris and he advised that he would provide us with a quote to build a base for the shed. The cost of the project will depend on the extent of the excavation required for the base and the amount of fill required. He will advise soon and the Board will make a decision upon receipt of the quotation.
