- (1) Campaign – The members agreed to a “Distracted Driving” campaign and Naomi Davison, Chair, will coordinate with the Town of Georgina’s Communication Department to move this forward.

- (2) New area(s) of interest for further investigation (ongoing agenda item).

(a) Signage indicating a “Stop Sign Ahead” warning was requested for the area at Arlington and Richmond Park Drive. These roads connect The Queensway and Woodbine. A study was conducted and it was estimated that 1500 cars travel these roads daily. The reason there is a concern is that the road curves at Arlington so the driver needs to be prepared for a sharp curve and it was recorded that when drivers come to do this that most are rolling through it. The police have been there about 68 times and issued at least 102 tickets for not stopping. Naomi Davison will take this issue up with Scott Edwards, Roads Superintendent.

(b) Ice being pushed up on Lake Drive- Naomi Davison had already made the Town of Georgina’s Fire Chief aware of this situation.

(c) Parking area on Lake Drive and Kennedy Road near Willow Beach Park. People were concerned that when backing out of the parking area onto Lake Drive that they would get T-boned. Naomi Davison, Chair, will pass this information to Scott Edwards, Roads Superintendent.


