8. PRESENTATIONS

(1) John Tucker, CD – Scotia Road and Prosser Cres.

Mr. Tucker introduced himself with a brief background. His concern is in regards to Scotia Road and Prosser Cres. He believes that the speed limit is too fast and is especially dangerous due to the poor sightlines that occur when the outer boulevards are full of cars. He explained that neither of these two streets have a through fare so they only have one access. He stated that there are many kids in this neighborhood and some play on the streets. He would like the speed limit changed from a 50km to a 40km or less. He will also like caution signage for “children at play” posted on the streets.

The other issue he has is that there is not enough parking spaces and the ones that are available are too small to adhere to the current by-laws at all times; so he is requesting that even and odd parking are available all day and night long.

Councillor Naomi Davison will ask the Infrastructure & Operations Department what is involved in having the speed limit reduced to 40km.

Anna Belyntseva presented the concerns of local residents petitioning that they want speed bumps placed on Lake Drive East from South Drive to Salvation Road.

Regional Councillor Naomi Davison will present this petition to Council; if Council does not approve this then she will request the Infrastructure & Operations Department to come up with suggestions to solve this issue.
