i. Steve Jacobson thanked John McLean for his two years of service with the BIA. He then described the benefits of membership, which includes among other things having a paid web presence (website, Facebook, Twitter), access to Community Improvement Plan grants. Kat's Gallery has recently taken part in the Community Improvement Grant Program. Low interest loans up to \$10,000 are also available from South Lake Community Futures; Karyn Stone and Kathy Taylor commented in support of the grant programs

Steve Jacobson handed the Chair to Joel Lipchitz for the remainder of the meeting.

b. Election of New Directors

 Four members came forward to offer their assistance and fill vacancies on the board: Andrea Ruth, Leo Russo, Andy Dubrawski (represented by Alicia Dubrawski as he was called away for a family emergency), Jolene Semenchenko. Three calls were made for additional volunteers; none came forward.

Each delegate described their business and what they had to offer. Four written Proxy votes were presented to the Chair. It was determined who was eligible to vote (ie. BIA members only or their designate), and a closed vote was held.

The ballots were counted by Karyn Stone and Sean Columbus from the Town of Georgina.

Andy Dubrawski and Jolene Semenchenko were elected and welcomed to the Board.

Andrea Ruth provided a presentation seeking dissolution of the Board due to concerns with the inability to fairly represent all businesses on the Jackson's Point BIA Facebook page and disagrees with the format of the BIA financial statements. Andrea has not felt welcome by the association, has been prevented from participating in events, and was not provided with a bike rack therefore preventing her from participating in the Ontario by Bike program. Further, she is talking to OBIAA, has had no assistance and states the Board has already committed to purchase cake for July 1 event without seeking a quote from her.

Leo Russo indicated that he supports the dissolution of the Board because: he did not agree to Steve acting as his representative, two decorative street lights in proximity to his property are burnt out and the BIA should have them fixed. Leo feels the BIA should advocate on the part of the businesses.
