Thank you for your interest in our products.

We have a range of different products depending on your needs and budget. While it would be impossible to detail every option I am including a couple here to give you a ballpark. If you can provide me more specifics about your project I can give you a detailed estimate for it and also suggest some different alternatives that may help (for example we have several different styles of frame depending on the style of sign used).

For a standard 18x24 sign panel (10 year guarantee) with a powder coated aluminum frame and graphic design the cost runs about \$600+HST and shipping

For the same thing but with a 24x36 panel, the cost would be about \$750+HST and shipping.
