12. COMMUNICATIONS

(1) Briefing Note; Municipal Law Enforcement, Off-Road Vehicles (Sent to Council January 22, 2020)

Mike Hutchinson, Manager of Municipal Law Enforcement reviewed current Town policies and what the changes to legislation mean for Off-Road Vechiles. Following Mr. Hutchinson's update the Committee was invted to ask questions and provide feedback.

(3) Lighting Pricing

Lighting approved for trails (capital budget)

Ken McAlpine discussed differences between solar and wired lighting options. He advised the Committee he planned to have someone from York Region Police attend to provide a crime-prevention perspective.

(4) Signage for Hodgson Trail

Ken McAlpine and Stephanie Fraser presented a signage package – that includes a map, places of interest, and trail etiquette and described the trails. The pair also presented a Wetlands signage package designed for Hodgson Trail with additional information on the different types of wetland, native plants, species at risk.

Ken McAlpine advised of upcoming trail projects including the Treasure Hill Trail and the a new (east – west trail) to be added to the ROC Campus. The new trail at the ROC will increase accessibility from the parking lots (accessible spots) to the soccer pitches and Baseball Diamonds.

(5) Future Site inspection.

The Committee discussed conducting site inspections of the Hodgson Trail and the Zephyr Trai, which would have to be broken up into sections. The Committee advised they would firm up sites and dates at the next GTATC meeting.
