Georgina Town Council Sept. 15, 2021

Noise By-law exemption agreement between the Town of Georgina and Inland Iron and Metals

Council received the report and approved the recommendation for a noise by-law exemption from Inland Iron and Metals for a two-year extension to allow tractor trailers to be loaded on Sundays and statutory holidays between 10 a.m. and noon from Sept. 28, 2021 to Sept. 28, 2023. Inland Iron and Metals has requested and received an exemption since 2004.

Holiday celebration grant - historic downtowns

Council received the briefing note regarding funding for the Town's three Business Improvement Areas and the Pefferlaw Association of Ratepayers for their 2021 holiday celebrations to encourage shopping in these areas. The Economic Recovery Team will be providing each of the four downtown areas with \$4,000 for BIA initiatives planned for the balance of the year.

Motion from Councillor Dave Neeson for the Holland Marsh Polder Phosphorus Recycling Facility

Council endorsed a resolution from Councillor Dave Neeson regarding the Holland Marsh Polder Phosphorous Recycling Facility:

WHEREAS the Holland Marsh Polder Phosphorus Recycling Facility is a proposed \$40-million capital project by York Region;

WHEREAS the Facility will reduce phosphorous runoff in the Holland River and Lake Simcoe by up to 40% and thereby protect the Lake's watershed from algae growth, resulting in better protection for the region's aquatic habitats, increased ecosystem biodiversity and protection of drinking water sources; WHEREAS the federal government has announced funding of up to \$16 million for the Facility and York Region funding of up to \$25 million as part of their broader "Upper York Sewage Solution" scheme; WHEREAS further to the June announcement and introduction of the York Region Wastewater Act by the Ontario Minister of the Environment, Conservation and Parks, which, if passed, would "would put on hold the Environmental Assessment application for the Upper York Sewage" scheme;

- NOW THEREFORE BE IT RESOLVED that the Council of the Town of Georgina:
- 1. Request that York Region, the Government of Canada and the Province of Ontario work collaboratively to move the Holland Marsh Polder Phosphorous Recycling Facility forward notwithstanding the "paused" status of the broader Upper York Sewage scheme, including proceeding to an Environmental Assessment for the Facility commencing in 2021;
- 2. That further to the above request, the Province of Ontario support the funding of the Facility's construction;
- 3. That the Mayor be authorized to write a letter outlining the above, with copies sent to the federal Minister of Infrastructure and Communities; the Provincial Minister of the Environment, Conservation

and Parks; All Lake Simcoe Region municipalities, MPPs and MPs; York Region and the Lake Simcoe Region Conservation Authority.
