Georgina Town Council April 6

Proposed subdivision agreement – Ainslie Hill I and Ainslie Hill II

Council received the report and approved the recommendation to adopt a by-law authorizing the Mayor and Town Clerk to execute the subdivision agreement. Council also approved a recommendation to adopt a by-law to amend the Traffic By-law to regulate traffic and control the parking of vehicles in the Ainslie Hill subdivision. Council also approved the road closure of Dalton Road and Catering Road from the intersection of Dalton Road and Baseline Road to the intersection of Catering Road and Country Mile Lane, from May 6, 2022, to Sept. 30, 2022, subject to the approval of the Regional Municipality of York and the Town's Director of Operations and Infrastructure. The road closure is for road realignment, installing underground services and repaving affected areas of the existing road.

Continuation of electronic participation and resumption of in-person meetings

Council received the report and requested staff come back with a report regarding the flexible hybrid meeting. This format combines virtual and in-person meetings, allowing for the most flexibility and allows for a more gradual return to the Council Chamber. This option allows staff, Council members and the public the option to participate either in-person or virtually. Council asked staff to come back with information on the cost for technology and staffing resources, improved air flow and quality in the Council chamber, limits on the number of people in the room, and whether or not to hold some meetings in person or virtually.

Closed session

In regards to Closed Session Item 18.1(a) on the agenda under Section 239(2)(f) of the Municipal Act, being advice that is subject to solicitor-client privilege including communications necessary for that purposed regarding solicitor legal advice on proposed Aerodrome;

1. That Council receive the solicitor's advice and staff be directed to proceed accordingly.

In regards to Closed Session Item 18.1(b) under Section 239(2)(f) of the Municipal Act, being advice that is subject to solicitor-client privilege including communications necessary for that purposed regarding illegal site alterations;

1. That Council receive the solicitor's advice and the solicitor be directed to proceed accordingly and further, that staff be directed to take all appropriate action, including legal action, against anyone who violates the Town of Georgina site alteration and fill moratorium by-law.

In regards to Closed Session Item 18.1(c) under Section 239(2)(b) of the Municipal Act, being personnel matters about an identifiable individual including municipal or local board employees;

1. That staff be directed to proceed accordingly.

In regards to Closed Session Item 18.1(d) under Section 239(2)(f) of the Municipal Act being advice that is subject to solicitor-client privilege, including communications necessary for that purpose regarding Lake Drive Jurisdiction – judicial review;

1. That Council receive the solicitor's advice and that the solicitor be directed to proceed accordingly.
