On April 25, 2019 the Georgina Beach Parking Committee (GBPC) adopted the following resolutions with respect to their recent mandate:

RESOLUTION NO. GBPC- 2019-0002

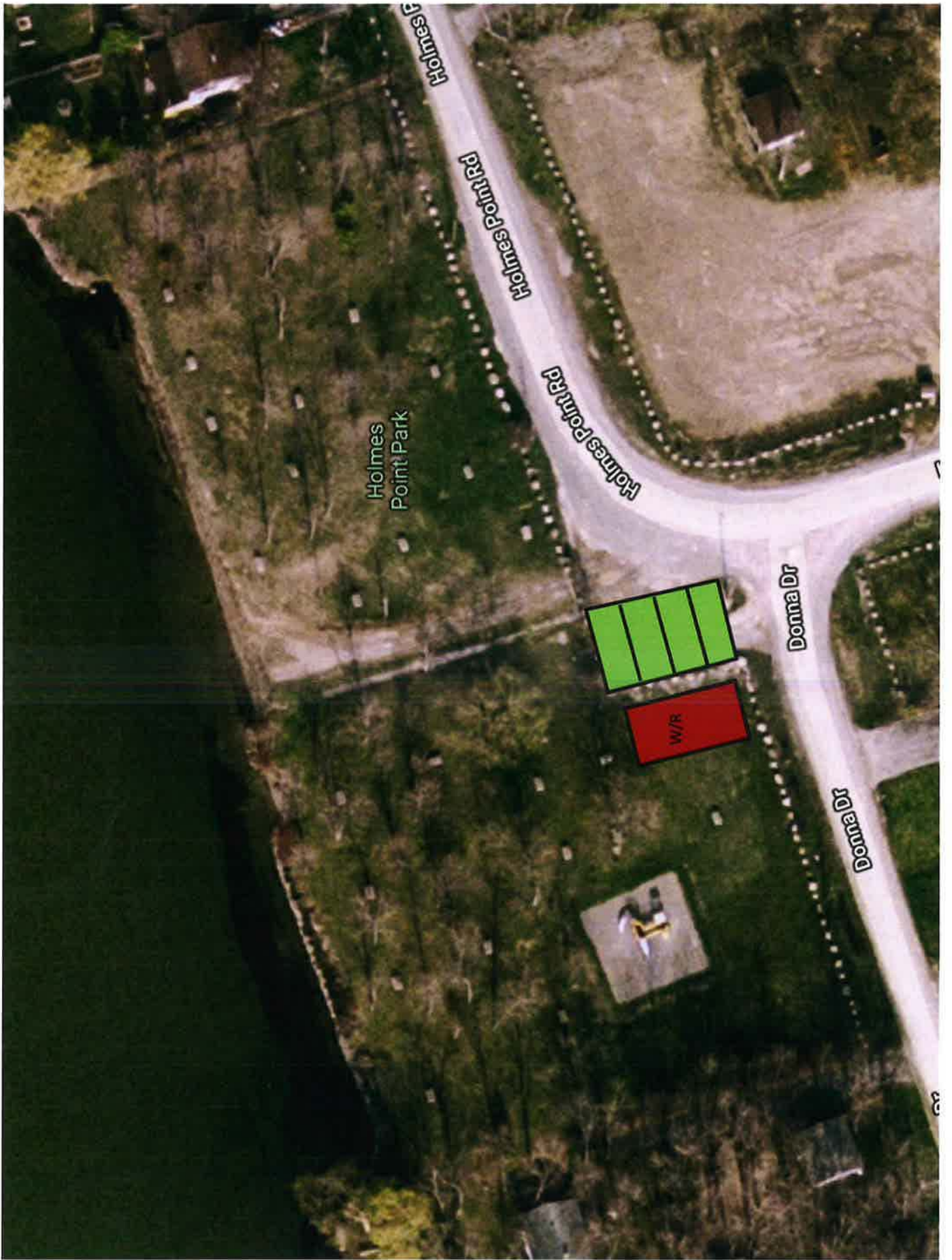
That the Georgina Beach Parking Committee recommend to Council:

1. That the first two most northerly rows of parking east of the chapel fronting the lake at De La Salle Beach be designated as Residents Only parking area on a trial basis and that signage be purchased and installed indicating the Residents Only designated parking spaces.
2. That two additional accessible spaces be created from four of the Resident Only parking spots. (Accessible spaces shall not be designated Residents Only Spaces.)
3. That the southern portion of the parking lot east of the chapel remain as parking available to residents and visitors.
4. That staff be directed to report back at the end of the season with comments regarding the pilot program and,
5. That staff be directed to explore using all the property to the east of lot for overflow parking.

RESOLUTION NO. GBPC- 2019-0003

That the Georgina Beach Parking Committee recommend to Council:

1. That staff be directed to explore creating a pilot Residents Only parking area for the 2019 summer season and report back to Council with an associating analysis.
2. Further that staff analysis consider the following areas for potential designation as resident only:
 - a. At Holmes Point Park, west of the bend on Holmes Point Road.
 - b. The corner lot on the south side of Donna Drive, west of Holmes Point Road.
3. That staff report back at the end of the season with comments regarding the pilot program.
4. That the Georgina Beach Parking Committee be dissolved and that in its place Council establish a working group consisting of Regional Councillor Rob Grossi, Councillor Dave Harding, Councillor Dave Neeson as well as relevant staff.
