CONTEST DURATION AND THEME

The Contest starts on Wednesday, July 1, 2020 at 1:00 p.m. EST ("Contest Period") and ends on Wednesday, July 1, 2020 at 6:00 p.m. EST.

The theme of the contest is "Canada Day Trivia".

ELIGIBILITY/HOW TO ENTER

Contestants must tune in to Georgina's Virtual Canada Day Contest through Facebook to access the links to answer the Trivia Questions.

A total of eight (8) questions will be presented via video clip at different times throughout Georgina's Virtual Canada Day 2020 event. Each question will have its own unique link.

Once the video clip of the trivia question has been presented online, a link will appear on the screen. This link will stay active for 10 minutes following the presented question.

Contestants will have 10 minutes to click the link and submit their answer, *which may include collecting personal contact information specifically in order to contact the winning recipient. (Personal contact information collected during the contest will not be used for any other purpose.)*

Once the 10 minutes are completed, the link for the particular question will no longer be available, and the answering period will have closed. Names of contestants who answered each question correctly will be collected (separately for each question) and a winner will be chosen at random to win a \$25 Harvey's gift card and two cookies from Cake's by Jez (one prize per question – eight (8) prizes in all for eight (8) individual winners).

Winners will be contacted on or before Thursday, July 9, 2020 via the contact information, they provided to be notified of their prize and the method in which they can obtain their prize.

Privacy Statement as it applies to GEORGINA'S VIRTUAL CANADA DAY 2020 - CANADA DAY TRIVIA CONTEST

The Town of Georgina recognizes our responsibility to protect the personal information provided to us. In brief, "personal information" is information that can be uniquely identified with you, such as your full name, address, email address and phone number for the purposes of your entry into THE GEORGINA'S VIRTUAL CANADA DAY 2020 - CANADA DAY TRIVIA CONTEST (the Contest).

2. IDENTIFYING PURPOSES

The Town of Georgina is collecting personal information in this instance solely for your entry into the Contest.

3. CONSENT

Your knowledge and consent are required for the collection, use or disclosure of personal information about you.

4. LIMITING COLLECTION

The Town of Georgina will limit the collection and use of both the amount and the type of personal information to that which is necessary for the identified purposes, for the management and oversight of the data collection, to ensure compliance with this privacy policy as it applies to the Contest and to preserve the integrity of the Contest database, or to comply with applicable laws and/or regulations, and any such information will be obtained only by lawful and fair means.
