



<p>I/we the undersigned, hereby apply for a "pool permit" in accordance with the information set forth in this application: I/we hereby agree to comply with all applicable laws and regulations (municipal and otherwise) pertaining to the issuance of this permit. I/we agree to maintain the pool in good repair, in addition to ensuring that the enclosure/fence surrounding it is maintained to preserve security and safety. I/we agree to NOT alter the existing grade of the property, nor disturb or interfere with existing drainage swales. I/we further agree to remove all excavated material from the property. It is expressly understood that neither the issuance of this permit, nor the carrying out of inspections by the Town of Georgina, will relieve the permit holder from ensuring continued compliance with the terms and conditions of this permit. I/we agree to rectify any issues of non-compliance that may come about as a result of erecting the pool on the subject property.</p>
