BY-LAW NO. 90-35 (PWE\_1)

Being a By-Law to prohibit and regulate the discharge of guns or other firearms, air-guns, spring-guns, cross-bows, long-bows, or any class or type thereof in the municipality or in any defined areas thereof.

WHEREAS Section 210 (29) of The Municipal Act allows Municipal Councils to pass by-laws prohibiting or regulating the discharge of guns etc., for the purpose of public safety.

NOW THEREFORE the Council of the Corporation of the Town of Georgina hereby ENACTS AS FOLLOWS:

1.
  - a) "Conservation Officer" means a Conservation Officer or Deputy Conservation Officer appointed pursuant to the Game and Fish Act;
  - b) "Council" means the Council of the Corporation of the Town of Georgina;
  - c) "Defined Areas" include all lands designated in Schedule "A";
  - d) "Firearm" means every kind, class and type of guns, air-guns, spring-guns, cross-bows and long-bows;
  - e) "Canine Control Officer" means a person appointed by the Town of Georgina as Canine Control Officer or an employee of such person;
  - f) "Peace Officer" means a member of a police force;
  - g) "Trapper" means a person licensed by the Ministry of Natural Resources to hunt furbearing animals.
  - h) "Farmer" means a person whose chief occupation is farming and who is living upon and tilling his own land or using it for animal husbandry or land to the possession of which he is for the time being entitled or who is a bona fide settler engaged in clearing land for the purpose of bringing it to a state of cultivation.
2. No person shall discharge any firearm within the "defined areas" of the Corporation of the Town of Georgina except:
  - a) the following persons in the course of carrying out his or her duties:
    - 1) a Peace Officer;



- 2) a Canine Control Officer;
  - 3) a Conservation Officer;
  - 4) a Trapper.
- b) a Farmer or tenant with consent from the Farmer upon lands owned and occupied by him or her may discharge a firearm for the control of birds, pests or animals injurious to his or her crops or property, provided that no shot or bullet shall pass over the boundary of the said land;
- c) a Person having in his or her possession all necessary licenses, required by the laws of the Province of Ontario and the Dominion of Canada, to permit the Person to hunt and to carry and discharge a long-bow or cross-bow, upon a Landowner's land within the following tracts of land, providing the Landowner has ten (10) acres or more and has given his or her written consent.
- 1) all lands within Concession 9 of the former Township of North Gwillimbury bounded by Woodbine Avenue, Metro Road, Baseline Road and the easterly limits of lot 15,
  - 2) all lands located within Concession 2 and 3 of the former Township of North Gwillimbury bounded by The Queensway North, Woodbine Avenue, Boyers Sideroad and the southerly limits of lot 17,
  - 3) all lands located within Concession 2 and 3 of the former Township of North Gwillimbury bounded by Metro Road, Boyers Sideroad and Varney Road.
3. No person shall discharge a firearm anywhere in the Town of Georgina, outside of the "Defined Areas" except;
- a) a Peace Officer in the course of his or her duties;
  - b) a Canine Control Officer in the course of his or her duties
  - c) a Conservation Officer in the course of his or her duties;
  - d) a Trapper in the course of his or her duties;
  - e) a Landowner or tenant with consent from the Landowner, upon lands owned and occupied by him or her may discharge a firearm for the control of birds, pests or animals injurious to his or her crops or property, provided that no shot or bullet shall pass over the boundary of the said land;
  - f) a Person having in his or her possession all necessary licenses, required by the laws of the Province of Ontario and the Dominion of Canada, to permit the Person to hunt and to carry and discharge a firearm, may discharge a firearm upon a Landowner's land provided the Person has the Landowner's consent;


- g) a Person in a firearms competition or other event, as approved by resolution of Council, shall be permitted on the Civic Centre lands located on Lot 6 Concession 9 of the former Township of North Gwillimbury.
  - h) a Person in a firearms competition or other event as approved by resolution of Council, and the Council may attach such conditions thereto as deemed appropriate and necessary to such approval.
  - i) a Person who is a member of the Belhaven Legion in good standing, and their guests only, shall be permitted on these lands described as comprising the northerly portion of Lot 15, Concession 5, provided that shotguns only shall be discharged on these lands during the months of January, February, March, April, September, October, November, and December in any calendar year and the days and hours of the shoot shall only be held on a Saturday between the hours 11:30 a.m. and 5:00 p.m.
4. Any person discharging a firearm in contravention of the provisions of this By-law shall be guilty of an offence and upon conviction shall forfeit and pay a penalty of up to \$2,000.00 exclusive of costs, recoverable under the Provincial Offenses Act
5. THAT By-Law No. 224 and 841 previously enacted by the Council of the Town of Georgina are hereby repealed.


WHEREAS Town Council deems it advisable to amend Schedule "A" to by-law 90-35 (PWE-1).

NOW THEREFORE the Council of the Corporation of the Town of Georgina hereby ENACTS AS FOLLOWS:





west of the Baldwin Pond,


AND WHEREAS Town Council deems it advisable to  
amend Schedule 'A' to By-law 90-35 (PWE-1).


NOW THEREFORE the Council of the Corporation of the  
Town of Georgina hereby ENACTS AS FOLLOWS:


That By-Law No. 90-35 (PWE-1) is hereby
