**BEING A BY-LAW TO FURTHER AMEND LICENCING BY-LAW NO. 2002-0169 (LI-3) RESPECTING REFRESHMENT VEHICLES, CARTS AND BICYCLES**

WHEREAS the Council of the Town of Georgina may, pursuant to the Municipal Act, as amended, enact by-laws for the licensing, regulating and governing of businesses and occupations in the Town of Georgina;

1. That Appendix 'B' to Licensing By-law No. 2002-0169 (LI-3) is hereby deleted in its entirety and replaced with Appendix 'B' attached hereto.
2. That subsection 3(20) of Schedule 10 to Licensing By-law No. 2002-0169 (LI-3) is hereby deleted in its entirety.
