FEES AND CHARGES
FIRE AND EMERGENCY SERVICES, AMENDMENT NO. 1

BEING A BY-LAW OF THE CORPORATION OF THE TOWN OF GEORGINA TO AMEND BY-LAW 2004-0131 (FI-4) TO ESTABLISH FIRE AND EMERGENCY SERVICES FEES IN THE TOWN OF GEORGINA, IN THE REGIONAL MUNICIPALITY OF YORK.

WHEREAS Section 391 of the *Municipal Act, 2001* as amended authorizes a municipality to impose fees or charges on any class of persons for services or activities provided or done by or on behalf of the municipality;

AND WHEREAS the Fire Protection and Prevention act, 1997, as amended also authorized a municipality to establish a Fire Department to provide fire fighting and fire protection services and for participating in an emergency services program;

AND WHEREAS, Council for the Town of Georgina passed By-Law 2004-0131 on December 13, 2004 and By-law 2004-0131 now requires amendment and updating;

NOW THEREFORE, the Council of the Corporation of the Town of Georgina, in the Regional Municipality of York, hereby enacts as follows:

1. ADMINISTRATION

1.1 That By-Law 2014-0131 is hereby amended by adding the following new section 5.1:

5.1 WATER/ICE RESCUES

If the Georgina Fire Department responds for water/ice rescues on Lake Simcoe during periods that warnings have been issued by Police or Fire Services, Lake Simcoe Region Conservation Authority or other agencies that ice conditions are unsafe, or where weather conditions have made for unsafe conditions, or where it would be reasonably known that ice conditions are unsafe, a fee shall be charged to the person(s) rescued as stipulated in Schedule 'A' attached to this by-law.

If the Georgina Fire Department responds to a reported motor vehicle collision on Lake Simcoe involving a snowmobile, automobile, ATV or other motorized vehicle the driver shall be charged a fee as stipulated in Schedule 'A' attached to this by-law.

2 CONFLICTING LEGISLATION

2.1 If this By-law conflicts with the provisions of any Act, other than the Municipal Act, the provisions of the Municipal Act prevail to the extent of the conflict.

3 VALIDITY AND SEVERABILITY

3.1 It is hereby declared that notwithstanding any section, subsections, clause, paragraph or provision of the By-law or parts thereof, may be declared by a court of competent jurisdiction to be invalid, unenforceable, illegal or beyond the powers of Council to enact, such section or sections or parts thereof shall be deemed to be severable and that all other sections or parts of this By-law are separate and independent therefrom and enacted as such as a whole. Same shall not affect the validity or enforceability of any other provisions of this By- Law or of the By-law as a whole.

3.2 Whenever any reference is made in this By-law to a statute of the Legislature of the Province of Ontario, such reference shall be deemed to include all subsequent amendments to such statute and all successor legislation to such statute.

4. SHORT TITLE


4.1 This By-law shall be cited as the FEES AND CHARGES FIRE AND EMERGENCY SERVICES, AMENDMENT NO. 1.
