# **CONTEST DURATION AND THEME**

The Contest starts on Friday, October 13 at 8:30 a.m. EST ("Contest Period") and ends on Friday, December 15 at 4:30 p.m. EST.

The theme of the contest is "Healthy Harvest: Choose to boost your veggies and fruit". Images, recipes and tips must demonstrate how children and young adults (with or without parents/guardians) make vegetables and fruit a part of their everyday lives. Throughout the contest period, a weekly winner will be drawn at random from the submitted entries.

# **ELIGIBILITY**

No purchase is necessary to enter. Georgina Residents are only eligible to win one Healthy Kids Community Challenge Georgina contest per calendar year.

Contest is open to all residents of the Town of Georgina.

To be eligible to participate in this Contest, each person entering the Contest must:

- Submit at least one (1) photograph, recipe or tip with the theme of the contest 'Choose to boost your veggies and fruit'
- Provide a description and the location of the photo, tip or recipe (include the hashtags #HealthyKidsTOG & #ChooseToBoostVeggiesAndFruit in photo description)
- Complete the Photo/Recipe/Tip Release Waiver form and read/agree to the Official Contest Rules and Regulations
- Not submit the same photo, recipe or tip more than once

Contestants meeting these criteria will be included in a chance for a prize resulting from a weekly random draw.

During the Contest Period, valid contest entries ("Entries") will be accepted through Woobox (which is accessed via a link from The Town of Georgina's Facebook page) or by email to communications@georgina.ca.
