| ► RP | The anticipation is that we will have an approved Secondary Plan by the beginning of summer 2020 |
| ►SB | By the time the KSP is finished, the YR MCR will not be completed. Therefore, it will have to be in conformity with existing Plan. We may have to finalize the Plan, but hold off on the approval until the MCR is complete. That being the approach other YR municipalities are currently taking. |
| ► HWL | Indicated that we will not be approving development applications in Keswick until the new KSP is approved. |
| ► RP | Will be reviewing corridors and their boundaries / structure and ground-truthing the NHS. |
| ► SN | Will the KBP SP be reviewed or looked at through this review? |
| ► RP | No, but we need to consider it in terms of the commercial / retail land analysis occurring in the KSP. |
| ► SN | Suggested to indicate the KBP SP on the KSP land use plan. |
| ► KS | Can new community Improvement Plan area(s) to be incorporated into the KSP? |
| ► RP | Yes, we can consider this as part of the review. |
| ► TM | Proposed Keswick Municipal Servicing Assignment Program, part of Georgina Housing Strategy, needs to be considered going forward. →4,000 p.e. of servicing to be released by YR in last phase, unsure of how many units will be set aside for Program. →Program is intended to require all new subdivision developments to provide a greater range of built forms (i.e. the missing middle; semi's, towns, multi-unit buildings) in exchange for servicing allocation. →Program details (i.e. criteria and requirements) yet to be created. |
| ▶ RF | Issues with ROW's: have become smaller, density has gone up, not enough parking trouble fitting utilities within crowed ROWs. A lot a "stuff" within ROW that were not previously considered – 20m (66 ft) ROWs are challenging. |
| ► HWL | It will be challenging to increase ROWs |
| ► DH | Complete communities usually have smaller ROWs per provincial direction. |

| ► SB | YR Official Plan speaks to parking management Strategy as part of OP/SP preparation. |

| ► KM | Active transportation, updating Trails Master Plan soon, on-road and off-road trails to link to key areas of the Town. |
| ► RP | Regarding parks – 4 ha for 1,000 ppl is not do-able. |
| ► KM | Trying to provide larger park and open space as opposed to smaller parkettes scattered throughout a community. |
| ► RP | Urban parks – 10x more expensive and 10x more difficult to maintain but they are necessary. |
| ► RP | Changes in intensification targets? |
| ► JB | Density and intensification targets – too early in the process to say what the numbers will be as the work is on-going – Planning for Growth direction report is schedule for Q4, 2019. |
| ► RP | We are not looking at expansion of KSP at this time. If the Region determines it is required it will be directed top-down from the Region opposed to bottom-up proposal from Town. |
| ► MB | PPS changes may permit municipalities to manage wetlands. There are not many wetlands in Keswick though. If TPP needs assistance they can contact LSRCA for assistance. |
| ► SN | Have policies in place related to the health of Cooks Bay. |
| ► RP | Cultural Heritage is usually a First Nations concern – we will need to consult with Georgia Island First Nations and other First Nations/Aboriginal groups. |
| ► HWL | There is a need to include Intake Protection Zones into the KSP. |
| ► RP | We will need Planned street widths in the KSP in order to get widenings. Some plans include Regional ROW requirements, others direct the reader to the YROP |
| ► SN | Town is currently undergoing a broadband strategy. Broadband policies are being requested to be included in KSP. |
| ► SB | Sarah likes to go through YROP and identify what policies they are requesting to be included in OPs/SPs. She will forward this information. |
| ► KM | Urban design guidelines need review. |

| ► ZA | Creating a sanitary masterplan, there will be a need to run the water servicing numbers through GM BluePlan's program. |
