



Taste of Georgina Contest Rules

February 18 - March 6, 2022

1. Agreement: These rules govern the “Taste of Georgina” contest. No purchase is necessary to enter the contest. The act of entering the contest constitutes acceptance of the contest rules and the decisions of the Economic Development and Tourism office at the Town of Georgina, which decision shall be final and binding on all entrants.
2. Eligibility: The contest is open to all residents of Georgina that have reached the age of majority, except for the Town of Georgina employees, their immediate families, and anyone living with any employee of the Town. Incomplete or illegible entries will not be accepted and will be disqualified. Photos of your dining experience at a participating Taste of Georgina restaurant must be able to be publically found on Facebook or Instagram by searching the #TasteOfGeorgina.
3. Campaign: Enter the contest by uploading a public picture to Facebook or Instagram from a Taste of Georgina participating restaurant’s special prix fixe takeout menu between 12:01 a.m. Feb. 18, 2022, and 11:59 p.m. on Mar 7, 2022. One winner will be chosen by random draw each week of the duration of Taste of Georgina (Feb 18 - Feb 26, 2022, and Feb 27 - Mar 6, 2022) for a total of two winners. An overall grand prize winner will be chosen at the end of Taste of Georgina. The winners will be contacted by Facebook or Instagram direct messaging by a representative of the Economic Development and Tourism office and must reply within 48 hours to maintain eligibility. If the winner cannot be contacted within this time period or fails to respond to any attempted contact, such potential winner will be disqualified, his/her entry will be declared null and void and the Town reserves the right, in their sole and absolute discretion, to select at random another eligible entry, in which event these provisions shall apply to such other eligible entry.
4. Prizes: (2) winners will receive one \$150 gift certificate each to a participating Taste of Georgina restaurant of their choosing. (1) winner will receive two (2) tickets to the Field to Table Dining Experience taking place the weekend of Aug 20, 2022. This prize is valued at approx \$180.
5. Release: Prior to receiving the prize, the winner will be required to show a valid photo ID and to sign a declaration of eligibility form releasing the Town of Georgina from any and all liability in connection with the contest and or the prize, confirming compliance with the rules and consenting to the use of his or her name testimonial, photograph or video, in any and all forms of media, without further compensation, in any publicity carried out by the Town of Georgina.
