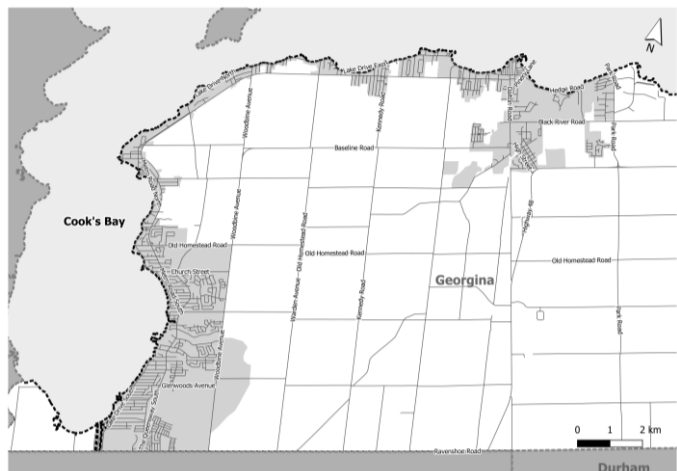




### Notice of Public Information Centre Town of Georgina Sanitary Sewer Model and Master Plan Municipal Class Environment Assessment

The Town of Georgina has started a Sanitary Sewer Master Plan to evaluate existing wastewater infrastructure and determine its capacity to accommodate future population growth. This Master Plan will also support capital improvement programs and assist with the preparation of the Town's development charge by-law.



#### How is this study being done?

This study is being done in accordance with Approach #1 of the master planning process as set out in the Municipal Class Environmental Assessment (EA) (October 2000, as amended in 2007, 2011 and 2015), which is an approved process under the Ontario Environmental Assessment Act. This approach involves the preparation of a master study document at the conclusion of Phases 1 and 2 of the Class EA process.

#### How can I participate in this study?

**Residents are invited to participate in a virtual Public Information Centre (PIC).**

The Town invites residents to view the study's evaluation results and preliminary preferred recommendations through

a virtual public consultation centre. This is an opportunity to learn more about the project and submit comments to the project team. The virtual PIC will present the following:

- Project overview
- Existing and future sanitary system issues
- Preliminary sanitary sewer system improvement alternatives
- Recommended sanitary sewer system improvement options
- Preliminary capital program

The virtual PIC presentation, with video narration, will be available on the Town's website starting Feb. 1, 2021. The slides and transcript will be available for download on the Town's website. You may also complete a short survey on the website to provide comments.
